IN 2024, A TOTAL OF 148 MEN AND WOMEN WERE ENROLLED IN OUR WORKFORCE DEVELOPMENT PROGRAMS. 114 PARTICIPANTS COMPLETED 1+ PROFESSIONAL CERTIFICATIONS INCLUDING SERVSAFE, COMPTIA COMPUTER, ROOTS OF SUCCESS ENVIRONMENTAL SPECIALIST, GED, FORKLIFT. 51 PARTICIPANTS EITHER COMPLETED PAROLE/PROBATION OR REPORTED HAVING THEIR CRIMINAL RECORD SEALED/EXPUNGED. 56% GRADUATES WERE PLACED IN EMPLOYMENT (24% ABOVE THE DFSS AVERAGE FOR TRANSITIONAL JOB PROGRAMS IN CHICAGO).
